OVERVIEW

- German copyright law provides for a € 500 pre-litigation settlement administrated by the court system
 - The process for the copyright owner to get the identity of the seeder from the ISP and get the settlement offer is administrated by the court and not subject to controversy like in the United States
- When the German citizen gets the pre-litigation settlement demand by paper mail, if they contest it, they go to a German copyright court designed to hear these types of complaints
- Rightscorp (RC) will present very strong evidence sample files that can be played in court as evidence



BUSINESS MODEL

- RC to partner with Kauder Germany to collect and enforce client copyrights in Germany
- RC to distribute net profits from German infringements to clients
 - Expenses to include:
 - All payments to Kauder for enforcement activities in Germany
 - 12.5% of gross receipts to RC for data acquisition
- RC clients paid quarterly
- RC and clients to share net profits on a 50/50 basis
- Client will receive a statement with composition and amount collected

STEPS OF ENFORCEMENT PROCESS IN GERMANY

- Document infringement in Germany
- File request for identity of infringer with German ISP
- If ISP refuses to release name, file request for a court order ordering ISP to provide information
- Send warning letter via German mail to infringer, which includes:
 - cease and desist declaration addressed to user; and
 - €500 settlement offer, payable within 14 days



STEPS OF ENFORCEMENT PROCESS IN GERMANY (CONT'D) POSSIBLE OUTCOMES

- Accept settlement and payment of settlement
 - End of proceeding
- No reaction
 - Reminder with 14 day deadline and possible action
 - Payment = end of proceeding
 - No payment = RC/Kauder decide to initiate proceedings
- User disputes infringement
 - Reminder with 14 day deadline and possible action
 - Payment = end of proceeding
 - No payment = RC/Kauder decide to initiate proceedings
- User acknowledges infringement, but no payment
 - Reminder with 14 day deadline and possible action
 - File default summons
 - Pursue German court proceedings
