The closing of the Asset Purchase Agreement is conditioned on VoicelInterop's business

being spun-off from Cleartronic in the second or third quarter of fiscal 2018. VoiceInterop will file a Form S-1 registration statement with the SEC to register the shares being distributed to Cleartronic shareholders and the shares being issued to the shareholders of CanniPlus Global, Inc. VoiceInterop also intends to register its common stock under the Exchange Act.

Larry Reid, President of VoiceInterop stated, "We are extremely excited to enter the medical Cannabidiol ("CBD") marketplace. Numerous studies and recent news articles show that CBD use is increasing worldwide and the timing of our entry into this market space could not be better."

"Prior to our acquisition of the assets and IP, CanniPlus launched a new line of CBD products. In addition, CanniPlus signed exclusive consulting and distribution agreements with Florida based Medical Marijuana Consulting Group ("MMCG") and HL Medical, Inc.," said Reid. Studies suggest that CBDs may lead to relief of pain, stress and anxiety. Our HL Medical Doctor network will provide clients with evaluations and recommendations on the use of our CBD products."

Reid closed by stating, "At 12 noon on Thursday, April 26th, 2018, I will be appearing LIVE in studio on 740 AM, 103.9 FM and 96.9 FM to discuss the CanniPlus Transaction. I will be interviewed by long time radio show host Mick Bazsuly. His show will be broadcast all around South Florida as well as worldwide on www.wsbradio.com and filmed on AMP2.TV.
