## \$40,000 Grant Awarded to Develop Winning App

MDC 2015 is open to all enrolled undergraduate and graduate college students or teams enrolled at any of the 28 eligible universities: Arizona State U; California Institute of Technology; California Polytechnic State U; Chapman U; Claremont McKenna College; Harvey Mudd College; Loyola Marymount U; Pepperdine U; Pomona College; San Jose State U; Santa Clara U; Simon Fraser U; Stanford U; U of Arizona; UC (all 10 campuses); U of Maryland, College Park; U of Oregon; U of Southern California; and U of Washington.

### **PRIZES**

Finjan MDC 2015 will award the top three finalists, including the winner, an iPad (WiFi). The winner will also receive a \$40K Grant for developing the winning app, have access to a professional app developer who will serve as a mentor and assist with developing a budgetary and technical project plan, and a possible offer for internship with Finjan.
