In addition, their expertise in project management and time-based systems supporting FAR and CAS compliance for commercial firms and OMB Circular compliance for grants management will add a significant expertise to SWK's capabilities. With over \$1.2 million in sales in 2012, the Company also provides a broad range of technical services, training and support to its customers, which are largely concentrated in the greater Washington, D.C. market.

"This potential acquisition will further strengthen SWK's national presence and materially enhance the Company's depth of specialized expertise in key niche sectors of the business management solutions marketplace," stated Mark Meller, Chairman and CEO of SilverSun.

Jeffrey D. Roth, Chief Executive Officer of SWK, added, "The acquisition of VICOR will

Subject to further due diligence and certain closing conditions, a definitive agreement is expected to be signed and the transaction completed on or before July 31, 2013. Detailed terms and conditions of the proposed transaction were not disclosed.
