OncoSec is a biotechnology company developing DNA-based intratumoral immunotherapies for the treatment of cancer. The Company's investigational technology, ImmunoPulse®, is designed to enhance the local delivery and uptake of DNA-based immune-targeting agents, such as IL-12. In Phase I and II clinical trials, OncoSec's lead program, ImmunoPulse® IL-12, demonstrated a favorable safety profile and evidence of anti-tumor activity in the treatment of various skin cancers as well as the potential to initiate a systemic immune response. ImmunoPulse® IL-12 is currently in Phase II development for several indications, including metastatic melanoma and triple negative breast cancer. In addition to ImmunoPulse® IL-12, the Company is also seeking to identify and develop new immune-targeting agents for use with the ImmunoPulse® platform.
