According to <u>Forbes</u>, as of December 2017, more than \$4 billion had been raised by investors investing in companies through cryptocurrencies. Mr. Blyumkin went on to state, "It is clear that billions in capital is looking for assets to purchase using cryptocurrencies. We want to harness that liquidity to increase value for our shareholders. That is why we are developing the tools to enable cryptocurrency-based investors to participate in future Petroteg offerings."
