SEACOR ANNOUNCES CLOSING OF THE EXCHANGE

FORT LAUDERDALE, Fla., May 15, 2018 (GLOBE NEWSWIRE) -- SEACOR Holdings Inc. (NYSE:CKH) ("SEACOR") today announced that it closed the previously announced exchange of \$117.8 million in aggregate principal amount of the Company's outstanding 3.00% convertible senior notes due 2028 (the "Old Notes") for a like principal amount of its 3.25% convertible senior notes due 2030 (the "New Notes") (the "Exchange"). The conversion rate for the New Notes is initially 13.1920 shares of the Company's common stock per \$1,000 principal amount of New Notes compared to 12.5892 shares of SEACOR's common stock per \$1,000 principal amount of the Old Notes. The conversion rate for the New Notes is equivalent to a conversion price of approximately \$75.80 per share, compared to approximately \$79.43 per share for the Old Notes.

Charles Fabrikant, Chairman and CEO commented: "We consider this Exchange prudent management of the balance sheet, spreading our maturities, and fixing the cost of borrowing at a time when interest rates could continue to move up. We issued the New Notes with a contingent interest feature which allows SEACOR to deduct for tax purposes the interest cost that would be attributed to a senior note, while paying a cash coupon of 3.25% at a time when short term rates are close to 2.00% and could well move higher. The combination of the tax deduction and rate environment for Treasury bills and certificates of deposit offsets any negative carry while securing long term liquidity. The New Notes position SEACOR to pursue its growth trajectory organically and through acquisitions."

SunTrust Robinson Humphrey, Inc. acted as the sole exchange agent and lead financial advisor in connection with the Exchange.

SEACOR is a diversified holding company with interests in domestic and international transportation and logistics and risk management consultancy. SEACOR is publicly traded on the New York Stock Exchange (NYSE) under the symbol CKH.
