The Company set out to build a system that was unique in the industry focusing on a highly efficient design that was able to leverage manufacturing techniques commonly found in mass-production environments.

Upon completing many rounds of prototyping and testing, both in the lab and in real world environments, WindStream set up its manufacturing facilities in 2011 in a 50,000 sq. ft. facility in North Vernon, Indiana where it currently manufactures and ships its products to customers all over the world.
